1. Election of Chairman for 2025/26

To receive a verbal report from Torridge District Council Councillor, P Pennington.

Local government re-organisation is a major problem with Torridge currently having £15m in reserves, what would happen to this in a larger Unitary Authority.

The new re-cycling centre at Appledore due for completion in May 2026.

Concerns were expressed on reports that Liverpool Council were buying up new homes in the area to house their tenants. Torridge Council have no control on who buys houses from the developers.
